B. RULES FOR TRANSFER OF STUDENTSHIP

Preamble

These Rules have been drawn up to ensure benefits to the students of the Institute of National Repute within permitted norms and while safe-guarding the interests of the University.

The heart of the structure of these rules is its commitment to the encouragement of academic growth of the nation and achievement of the academic excellence.

1. APPLICATION FOR ADMISSION

- 1.1** The student of some pertinent institute of national repute as decided by the university and revised from time to time may apply to the Registrar of this university seeking the admission against Transfer of Studentship indicating the specific cause.
- 1.2** The application must be forwarded by the Head of the Institute.
- 1.3** The student must to provide the Academic Transcripts issued by competent authority of that institute along with the application/at a time during the processing of the application, fixed by the Registrar of Presidency University.

2. PROCESS OF TRANSFER

- 2.1** The application of the Transfer of Studentship is to be scrutinized and verified with the competent authority of that institute where the student is currently pursuing his/her study.
- 2.2** The Academic Program in which the student is pursuing its study must be verified by the Registrar so that it is relevant to the programme to which the student wants to transfer.
- 2.3** If the verification report is found in order and appropriate for transfer of studentship in this university by the Registrar, he may forward the application for consideration of the Vice Chancellor. The final permission regarding Transfer of Studentship shall be granted by the Vice Chancellor.
- 2.4** The Total number of students transferred from some pertinent institute of national repute (mentioned in clause 5) cannot exceed 10% of the existing intake of a particular department and a particular course.
- 2.5** This process of transfer is purely a matter of consideration and cannot be claimed as right.

3. TRANSFER OF CREDITS

The student may be allowed to transfer credits from a programme in institute of national repute (mentioned in clause 5). Credit Exemption may also be allowed in this regard. Credit transfer/exemption depends on whether the accumulated credit is relevant to the programme to which the student wants to transfer.

4. TRANSFER OF FELLOWSHIP

The student may be allowed to transfer fellowship/scholarship from a programme in the institute in which s/he is pursuing his/her study if the concerned authority of the said fellowship/scholarship allows.

5. LIST OF INSTITUTES TO BE CONSIDERED

Not excluding the provision of inclusion/revision, the list of some pertinent institutes of national repute includes the following:

- (i) I.I.Sc, Bangalore
- (ii) All other IISER
- (iii) S.N. BOSE N.C.B.S
- (iv) TISS
- (v) TIFR
- (vi) Chennai Institute of Mathematics

Notwithstanding anything contained in the Presidency University Act, 2010 (particularly in section 54) the students of erstwhile Presidency College on their own option (in writing) may also be allowed to avail this facility of Transfer of Studentship.

6. REMOVAL OF DIFFICULTIES

If on account of any lacuna or omission in the provision of this rule, or for any other reason whatsoever, any difficulty arises the decision of the Vice Chancellor shall be the final.
